Service Membership Information

The following persons may be eligible for admission as a Service Member:

- A person over the age of EIGHTEEN (18) years who has served with the Armed Forces (as determined hereunder) may be eligible to join the Club.
- – Membership shall be open to a Serviceman/woman, Ex-Serviceman/woman, Members of the Permanent Forces, and also Merchant Seamen who are eligible for membership of the RSL. Applicants must be of good character and reputation.

HOW TO APPLY

Applications for Service Membership of the Club are to be submitted on the Club's official 'Service Membership Application Form. An Applicant for Service Membership can only be nominated by a Life and/or Financial Service Member of the Kedron-Wavell Services Club Inc. The Applicant's Discharge Certificate (or evidence of Service) must be sighted and verified by the Board of Directors before the processing of the Application can begin. No application will be considered unless the appropriate service particulars are presented with the Application. The Membership fee is to accompany the Application. Refunds are made to unsuccessful applicants. Further information regarding Membership, Club Facilities etc may be obtained from the Club 7 days a week.

DEFINITIONS

'Serviceman/woman' - persons who are presently in the Armed forces of the Commonwealth.
'Ex-Serviceman/woman' - discharged member of the Naval, Army or Air Force of the Commonwealth or of the United Kingdom or any part of the Commonwealth of Nations or of any ally of the Commonwealth. The term includes a female who has served in any capacity with a service forming part of any such Force including service as a medical practitioner, nurse or masseuse.
