TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Terms and Conditions.
2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
3. Entry is only open to current financial members of Kedron-Wavell Services Club.
4. To be eligible for entry, member must join by the day prior of each draw night. Members who join on draw day are ineligible for that draw.
5. The winner must have suitable photo identification to prove identity.
6. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.
7. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. Members become eligible to win when actively playing a machine (with credits in it) during the promotional period and have their member card inserted.
9. Entries are earned for the 3 x guaranteed draws (7.30pm, 8.30pm & 9.30pm) every Tuesday night from 5pm with every \$5 turnover on the gaming machine with member card inserted.
10. Entries are earned for the Jackpot draw (10.15pm) weekly from 10.30pm the previous Tuesday night with every \$5 turnover on the gaming machines with membership card inserted.
11. Entry tickets are automatically generated through the Odyssey Promotion System.
12. Entries reset weekly .
13. Guaranteed draws at 7.30pm, 8.30pm and 9.30pm on the night of the draw.
14. Guaranteed prize of \$1,000 cash for every winner
15. Weekly Jackpot draw begins at \$1,000 and will increase by \$1,000 each week if not won.
16. Jackpot can reach a maximum of \$10,000 before it is guaranteed to be won.
17. Winners will have two (2) minutes within which to present themselves to the prize drawer. If the winner does not appear, they will forfeit their prize and it will be re-drawn until claimed. At the discretion of Management, the two (2) minute timeframe can be extended on the night for such reasons as high patronage and/or mobility of patrons presenting themselves to the prize drawer.
18. Winners will be determined using the Odyssey promotion system virtual barrel draw.
19. The winners name and membership number is announced throughout the club, however due to technical constraints and ambient background noise cannot it be guaranteed in all areas of the Club. The gaming cashier is the official draw location, and all announcements are best viewed from there.
20. The Promoter's decision is final, and no correspondence will be entered into.
21. Any deliberate misuse of points received or the exchange of points, cash, products or services with a third party will result in the winner's points balance being cancelled.
22. Prizes, or any unused portion of a prize, are not transferable or exchangeable.
23. All entries submitted become the property of the Promoter. Entries will not be returned to any entrant.
24. As a condition of entering into this promotion, each entrant licences the Promoter to use their entry in any media for an unlimited period for any reason including but not limited to future promotional, marketing or publicity purposes.
25. Each entrant warrants to the Promoter that each entry submitted is an original literary work of the entrant that does not infringe the rights of any third party. The entrant agrees to indemnify the Promoter against all costs and claims by third parties arising from a breach of this warranty.
