



**FRIDAY NIGHT MEMBERS DRAW – GO FOR \$20 GRAND  
COMMENCES FRIDAY 4<sup>TH</sup> FEBRUARY 2022**

**The promoter reserves the right to change the dates of the draws at any stage during the promotional period.**

**Members please note:**

All members that have a Kedron-Wavell card number (member number from 1 – 599,999) will be eligible to win the Kedron-Wavell Members Draw promotion.

Members who have a card from The Sands Social (member number 600,000 – 899,999) will not be eligible to win the Kedron-Wavell Members Draw promotion.

Members are able to change their preference of Venue (either Kedron-Wavell or The Sands Social) every 6 months. Please note that changing your preference will change your membership number. We cannot hold your member number for use at both venues.

**THE FOLLOWING RULES WILL APPLY IN CONJUNCTION WITH THE STANDARD TERMS AND CONDITIONS OF ENTRY**

1. Must be a KW member prior to the day of the draw. For draws on the 29<sup>th</sup> April 2022, members must have joined on or before the 28<sup>th</sup> April 2022.
2. Member must present a valid KW members card (2022 card) and photo ID when claiming the prize.
3. Cannot be a staff member, or family members living with staff.
4. Cannot be a Director or family members living with Director.
5. Must be *in the Club* at the commencement of the draw (not in the carpark).
6. The member must present within 3 minutes (additional time allowed when club is busy or member is frail) to the Cashier.
7. The draw cannot be heard in all areas of the Club (eg DOSAs). The Jackpot draw times are 6.30pm & 8.30pm so we encourage all members to be where they can hear or observe the draw.
8. We don't always pronounce names correctly; so we recommend members ensure they know or can quickly check their membership number. We always get the number correct.
9. If a winner comes forward, please be patient as we need to validate the member before confirming the win. This may take up to ten minutes, if members leave straight away, they may miss the re-draw.
10. Those that are attending functions will not be in the draw. Must be inside the club proper. The draws will not be heard in the function rooms.
11. To enter the guaranteed draws, a member must swipe their membership card from 5pm on 29<sup>th</sup> April to receive one (1) electronic entry in to the "\$5,000 Guaranteed Draws" promotion.
12. If the full \$20,000 Prize has not been claimed in either the 6.30pm or 8.30pm full members draws on the evening of the 29<sup>th</sup> April 2022, then the \$5,000 guaranteed draws will be held at 9.00pm, 10.00pm, 10.30pm and 11.00pm on the 29<sup>th</sup> April 2022.
13. Winners names will be announced at the above times and each will have three (3) minutes to claim their prize from the Kedron-Wavell staff member at the Gaming Room's Cashier. Redraws will take place until all four draws have been claimed.

#### STANDARD TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Terms and Conditions and all terms and Conditions are at the Management's interpretation.
2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
3. Entry is only open to current financial Kedron-Wavell "Active" or "Perpetual" members. Winner must be a financial member the day prior to the draw and hold an Active 2022 membership card or Perpetual membership card. The winner must be a Kedron-Wavell member at least 1 day prior to the draw.
4. The winners must have suitable photo identification to prove identity.
5. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
6. The promotional period runs every Friday night from the 4<sup>th</sup> February, 2022.
7. If the jackpot is claimed at any point throughout the promotional period, the promotion will end and no further draws will be conducted. This will be at the discretion of management.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.
9. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
10. The jackpot draws will take place and be announced throughout the entire club (excluding toilets, DOSA's and private event rooms) at 6.30pm and 8.30pm every Friday night during the promotional period (excluding select days as determined by the club).
11. There is not sound everywhere throughout the club so it is the responsibility of members to ensure that they are able to hear the draws.
12. The jackpot draws will be drawn from the entire Kedron-Wavell membership database. This draw will take place through the Odyssey Virtual Barrel Draw system in the Member's Draw program. No paper tickets will be issued. This may vary for the guaranteed jackpot draws.
13. The Members Draw jackpot is \$20,000. This value remains the same each week that the promotion runs.
14. Once the jackpot has reached the guaranteed draw date, there will be separate Terms and Conditions for how the jackpot will be given away (refer to above).
15. The overall prize is \$20,000 as approved by Office of Liquor and Gaming Regulation (OLGR) Kedron-Wavell Services Club's maximum cash component is \$5,000, with the remainder of the prize to be provided to the winner in a cheque/bank transfer. If provided by cheque it will be written out to the winner's name only.
16. The draws will take place via the Odyssey Virtual Barrel Draw. The member who is drawn out will have three (3) minutes within which to present themselves to the prize drawer. If the member does not appear, they will forfeit their prize. At the discretion of Management, the three (3) minute timeframe can be extended on the night for such reasons as high patronage and/or mobility of patrons presenting themselves to the prize drawer. Members must be present for the draws to be eligible to win. Suitable photographic identification and a 2022 Active or Perpetual Kedron-Wavell Membership Card must be presented to staff upon claiming the jackpot.
17. The staff member announcing the draws may not always pronounce names correctly; so we recommend members ensure they know or can quickly check their membership number. We always get the number correct.
18. The promotional draw will be deemed invalid if there are any errors / mistakes made by the club that affect the integrity of the draw.

20. The Club operates under a Covid capacity limit. COVID venue capacity means members may not get let into the Club if the Club is full.
21. The Promoter's decision is final, and no correspondence will be entered into.

22. If for any reason a winner does not take an element of the prize at the time stipulated by the Promoter, then the prize or that element of the prize will be forfeited.
23. If the prize (or any part of the prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification.
