PROMOTION SPECIFIC TERMS & CONDITIONS

- 1. By entering, claimants agree to be bound by these conditions. Claims must comply with these conditions to be valid. Information on how to claim form part of these terms and conditions.
- 2. Entry is only open to Australian residents aged 18 years and over, as well as conditions specified in Point 3 (three).
- 3. Entry is only open to members of Kedron-Wavell with a member number from 1 599,999 and members of The Sands with a member number from 600,000 to 899,999. Duplications of members in the system will make the member null and void to receive the prize (ie if the member is a member at both Kedron-Wavell and The Sands Social).

- 12. To win the member needs to present themselves to the Gaming Cashier within the allocated time frame.
- 13. Each winner drawn will have three (3) minutes to present themselves to the prize drawer at the Gaming Room Cashier. - 19. If the winner does not present themselves within the allocated time frame, they will forfeit their prize and it will be redrawn until a winner is found.
- 20. The draws will take place via the virtual barrel draw system provided by our Licensed Monitoring Operator.
