



LATE NIGHT DELIGHT GAMING PROMOTION

TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Terms and Conditions.
2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
3. Entry is only open to current financial members of Kedron-Wavell Services Club.
4. Promotion runs every night from 12am – 3am during the promotional period.
5. The Entry promotional period runs from the 1st of the month to the last night of the month
6. The winners must have suitable photo identification to prove identity.
7. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
9. Multiple entries are permitted. Members will receive one (1) entry for each \$5 turnover on a gaming machine (provided their own current valid membership card is inserted into a gaming machine correctly).
10. Entries can be gained from 12.00am until 3.00am (every night during the promotional period). Entry tickets are automatically generated through the Odyssey E-Promo. No paper tickets will be issued. Members can check how many tickets they have by swiping their membership cards at the kiosks. Entries will reset after the last draw at the end of the month.
11. Six (6) draws will take place & announced in the Gaming Room at 12.00am, 12.30am, 1.00am, 1.30am, 2.00am & 2.30am on the last day of the month during the promotional period.
12. Entries must be validated on the night of the draw by swiping their membership card in the Odyssey kiosk or using at the POS or gaming machines.
13. The prize will be given in the form of Kedron-Wavell Rewards points onto the winners account. Each winner will receive 50,000 rewards points (\$500)
14. The draws will take place via the Odyssey E-Promo. Each winner will have two (2) minutes within which to present themselves to the prize drawer. If the winner does not appear, they will forfeit their prize and it will be re-drawn until claimed. At the discretion of Management, the two (2) minute timeframe can be extended on the night for such reasons as high patronage and/or mobility of patrons presenting themselves to the prize drawer. Winners must be present for the draws to be eligible to win.
15. The Promoter's decision is final and no correspondence will be entered into.
16. The prize for each draw will be issued as cash.
17. Prizes, or any unused portion of a prize, are not transferable or exchangeable.
